

Today's credentialing marketplace is a confusing maze of certifications, degrees, certificates, licenses, badges and other credentials. Job seekers, students, and workers have more options than ever to help them get ahead, but a lack of transparency in credentials causes confusion for them and for employers looking to build their workforce. With the explosion in the number and variety of credentials over the past decade, there is an ever-growing need for these stakeholders to be able to easily understand and compare different credentials.

With support from Lumina Foundation, the George Washington University Institute of Public Policy, Workcred (an affiliate of the American National Standards Institute) and Southern Illinois University launched the Credential Transparency Initiative (CTI) in 2013 to create greater transparency in the credentialing system by:

1. Developing a common language, known as the Credential Transparency Description Language, for describing the key features (e.g., competencies, transfer value, third-party approval status, etc.) of all kinds of credentials, credentialing organizations, and the quality assurance bodies that accredit, approve, endorse, or recognize them.
2. Building a voluntary, web-based credential registry for aggregating and sharing the resulting comparable information.
3. Creating and testing a search-and-discovery application that enables access to this information by employers, educators, students, career counselors, app developers, and others.

This effort has been advised by an Executive Committee made up of senior representatives of the American Association of Community Colleges, American Council on Education, Business Roundtable, Committee for Economic Development of the Conference Board, National Association of Manufacturers' Manufacturing Institute, U.S. Chamber of Commerce Foundation, and University Professional and Continuing Education Association.

Lumina Foundation and the Business Roundtable are working now with the project team to transform CTI into Credential Engine, a new nonprofit to take the recently launched prototype registry to scale.

To ensure the relevance of its work, Credential Engine will engage advisory groups from four key stakeholder groups: postsecondary education institutions/systems; business; certification and licensure bodies; and quality assurance (accreditors, endorsers, approval and recognition bodies).

Credential Engine will maintain the Credential Transparency Description Language, Credential Engine Registry, and prototype search app (named WorkIt) under open source and content licenses (e.g., Creative Commons) in order to promote a competitive applications marketplace that will produce more specialized apps in the future.

Getting Involved

Credential Engine is currently working with numerous colleges, universities, certification, and other credentialing organizations that are participating as pilot-site partners by providing registry information on one or more credentials. Pilot-site partners receive technical assistance in publishing to the registry, learn about "linked data" and related Web 3.0 technologies, gain greater visibility in the market, and can shape the system's development.
