OVERVIEW

Local areas are in the midst of developing regional plans and local plans, as well as negotiating costs and services in memorandums of understanding (MOUs). Development of plans and MOU negotiations will continue throughout May. Following are important updates related to these activities.

- All 22 local areas submitted preliminary budgets as required by the Governor's Guidelines for negotiating costs of comprehensive one-stop centers and local service delivery systems. Preliminary budgets are currently under review by the budget review team, and a response will be issued to each local area prior to the final budget submission. In the meantime, local areas are to continue with negotiations for final budget submittal.
- Many of the Regional and Local Plans have been posted for public comment.
 Plans must be posted for a 30-day period to meet the public notice requirement.
- Questions continue to be received through the MOU FAQ process (see sidebar on page 1). The MOU FAQ document has been posted on the WIOA Implementation Portal with several updates, including the answers to questions from a three-part webinar series on the Governor's Guidelines.
- Commerce issued a <u>formal notice</u> in response to numerous questions received about timelines and the most recent guidance issued. The notice addressed previously issued guidance on regional and local planning requirements and Governor's Guidelines on negotiating costs and services.
- The notice also confirmed the delay in the implementation of criteria and procedures for certifying comprehensive one-stop centers until Program Year 2017/State Fiscal Year 2018.

REGIONAL AND LOCAL PLANS AND MOUS REVIEW PROCESS

A thorough <u>review pocess and timetable</u> have been developed by the Interagency Work Group in conjunction with a newly developed Regional and Local Plans and MOUs Review Subgroup of the Interagency Work Group. This process was approved by the Illinois Workforce Innovation Board Executive Committee on May 16, 2016.

For purposes of regional and local plan and MOU reviews, submission for a region will be deemed complete, and the 90-day period for the Governor's review of regional and local plans will begin, when the regional plan and all local plans and MOUs corresponding to the LWIAs within a region have been submitted. The only exception will be those regions in which one or more local areas fail to reach agreement on an MOU.

ILLINOIS INTEGRATED BUSINESS SERVICES ENVIRONMENTAL SCAN AND BEST PRACTICES PROJECT UPDATE

A key issue that has been identified through the WIOA planning process is the need to coordinate business outreach among required partners. The State of Illinois was provided a *Technical Assistance Award* from the U.S. Department of Labor to address this growing concern. The project, named the "Illinois Integrated Business Services Environmental Scan and Best Practices Project," will provide the State with an environmental scan of current business engagement and service delivery across identified workforce system partners.

The end result will be a "map" of current efforts to support alignment—understanding gaps, overlaps and opportunities for integration. Best practices will also be identified.

A virtual presentation of the final product will be given to the Interagency Work Group in the near future.
