Key Takeaways from USDOL-ETA Guidance

- Costs associated with the One-Stop Operator are programmatic, not administrative
- The bidding process through a Request for Proposal (RFP) or an Invitation for Bid (IFB) must include costs associated with the deliverable
 - Bids not having such costs restrict the bidding process

Key Takeaways from USDOL-ETA Guidance

- Revisions require public notification as well as direct notification to solicitors of the original request
- If there are no bids or no qualified bids, the process should be reviewed for necessary changes and a re-solicitation occur

Key Dates

- March 31 LWIBs submit "Notice of Intent to Apply"
- May 15 OSOs complete "Application for Certification"
- May 31 Center review completed
- June 15 OSO procurement completed
- June 15 Review team makes recommendation to LWIB
- June 30 LWIB notifies IWIB of certification decision
- July 1 IWIB sends designation letter to LWIBs

Key Takeaways from USDOL-ETA Guidance

- An evaluation process should be developed prior to solicitation and utilized that includes:
 - Factors and scoring procedures
 - Assignment of reviewers/panelists
 - Process for conducting the evaluation
 - Development of a competitive range
 - · Documentation of results
- Clear understanding of who is authorized to enter into and sign legally binding agreements on behalf of their agencies
