



HISTORICAL COUNTS OF COMMERCIAL DRIVES LICENSES (CDLs): 2010-2014**








## WIOA CDL TRAINING RESULTS & PERCENT OF ENROLLED PY10 - PY15 STATEWIDE





PY10 - PY15 STATEWIDE**




WIOA COMMERCIAL DRIVERS LICENSE TRAINING: NUMBER ENROLLED  
PY'10 TO PY'15 BY LWIA




WIOA COMMERCIAL DRIVERS LICENSE TRAINING: NUMBER EMPLOYED  
PY'10 TO PY'15 BY LWIA




WIOA COMMERCIAL DRIVERS LICENSE TRAINING: PERCENT EMPLOYED
