


# System User Audits & SDA Agreements

- User Audits
  - Over 300 Current Users have submitted updated or new forms
  - Shared Data Agreements with IDES and IBIS were included in the audit
- New Shared Data Agreements by OET are forthcoming for July 1, 2026
  - Intent is to incorporate into IWDS 2.0 as an automated, electronic process with electronic signatures
- Ongoing Technical Assistance by Kris Theilen
  - 2 Local Systems Administrator Trainings
  - Will need full compliance with the IWDS 2.0 deployment

  - WIOA Wednesday Webinars



# Eligible Training Provider List (ETPL)

- ETPL Coordinators working with New or Continuing Providers:
  - Verification of information
  - Authorized to operate training programs
  - Locations need to be verified
  - ONet/SOC - Training Program Critical Element
    - Prepare to inform Provider on associated ONet/SOC codes before immediate denial
    - Ie; When only a ".99" or "all other" ONet/SOC is submitted on application.
  - Utilize and Share Demand Occupation Training List (DOTL) Notice and List
  - Understand Outcomes: make correlations to a POS goal and outcome
  - NEW Step: Recommend to State ETPL Coordinator:
    - 30 Day Window to Recommend for ETPL or Recommend not meeting criteria

  - Add “Middle Eastern/North African” to Race/Ethnicity
  - Add “Military Connected Individual (Non-Priority of Service)
    - Active-Duty Military Spouse
    - Military Caregiver
    - Survivor
    - Veteran Spouse
  - New Fields for Long-Term Unemployed
    - Unemployed for 27 or more consecutive weeks
    - Not unemployed for 27 or more consecutive weeks, but DWG LTU
    - Unemployed for 27 non-consecutive weeks in past 12 months
    - Does Not Meet Conditions Described Above





  - State Relying on robust 3<sup>rd</sup> Quarter Performance Data for negotiations
  - What does this mean to LWIAs?
- MSGs
  - Current and real time reporting
  - Show a variety for students or employees
  - Find out how are you doing?
    - IPATS – Dashboard: IA, ID or Youth With or Without MSGs Recorded: XX
    - IPATS - Data Graphs: “LWIA Comparison”

- US DOL Data Validation [TEGL 23-19, Change 3](#)
  - Attachment II (Revised)- Source Documentation
  - Skills Progression (1810) **NEW:** Copy of a credential that is required for a particular occupation and only is earned after the passage of an exam



# Performance Assessments & Sanctions

- Revised Assessing Performance
  - Rescind WIOA Notice 21-NOT-01, Change 2 SAM Pilot Project
  - Revise to reflect PY2024 Assessments applying SAM adjustments
  - Clarify Individual Indicator Score and Successful Performance (*70% of adjusted level of performance*)
  - **Remove Overall Local Indicator Score (90%)**
  - **Remove Overall Local Program Score (90%)**
- New Performance Sanctions
  - Incorporate and Revise WIOA Notice 21-NOT-01 Sanctions
  - 1<sup>st</sup> Year Unsuccessful in a single indicator of performance
    - Local Technical Assistance Required
    - Optional Performance Improvement Plan (PIP)
  - 3<sup>rd</sup> Year Unsuccessful in Same indicator of performance in same WIOA Title I program
    - Corrective Action Plan including Development of Reorganization Plan
- New Appeals of Performance Sanctions Policy
