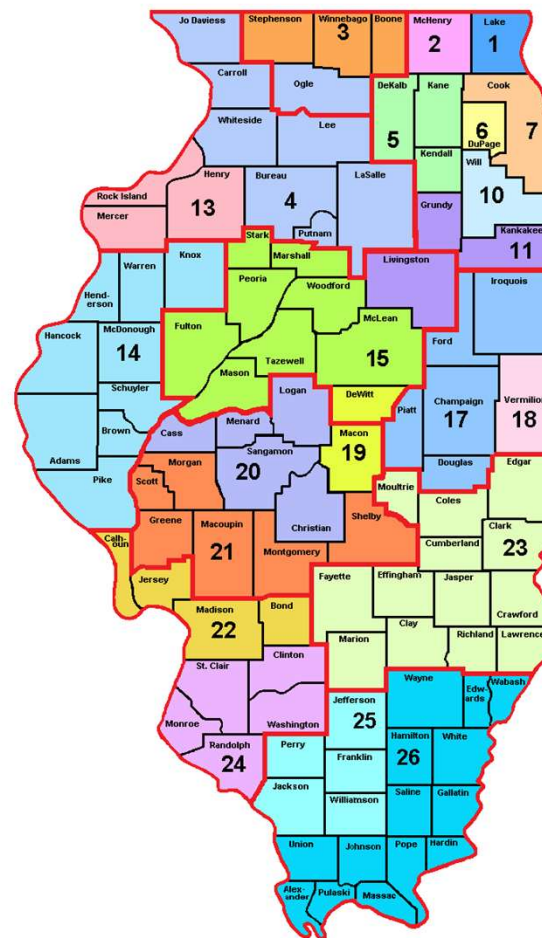

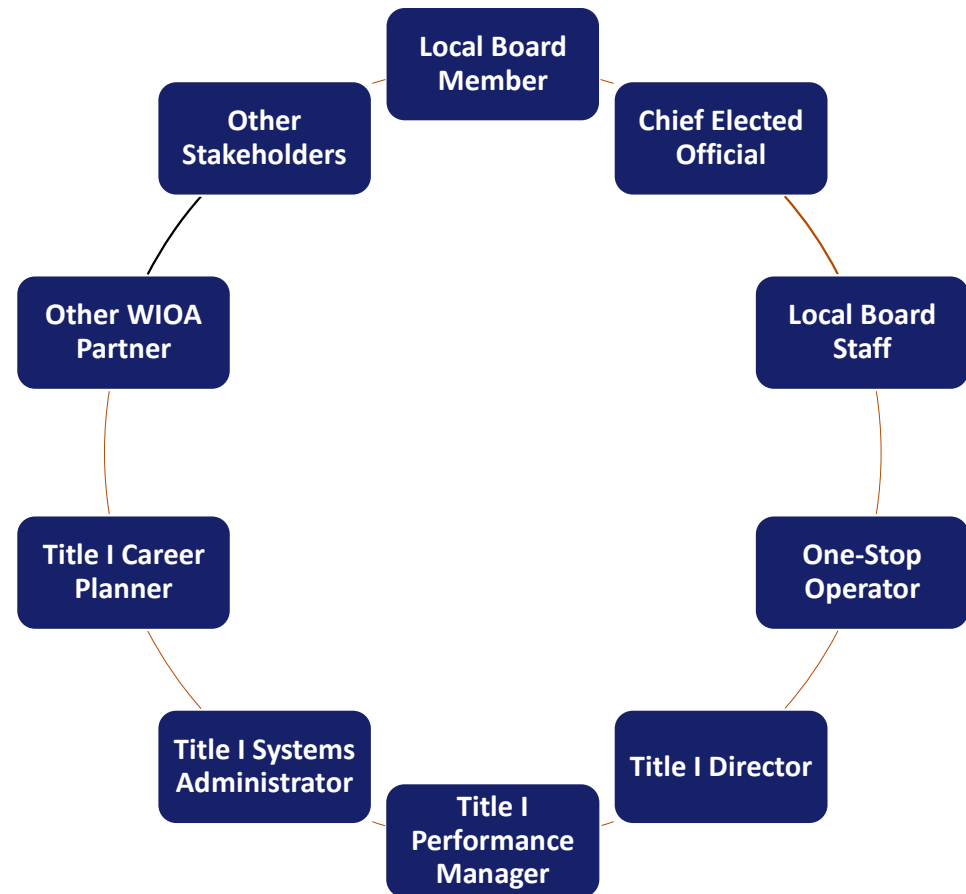

PY26-27 Local Performance Negotiations

- Revised Policy and Guidance
 - WIOA Policy 3.4 General Requirements for Negotiation of Local Performance Goals
 - WIOA Notice 20-NOT-01, Change 3 Local Performance Goals Negotiations
- Expected Levels of Performance
 - Justification included with Submissions
- Two Year Negotiations
 - Can Negotiation the Same or Different Level of Performance for each PY
 - Indicate Continuous Improvement
- Local Negotiation Team of up to 5 Members

PY26-27 Local Negotiation Cycle



- Local Negotiations

- June-July 2026 - Local Negotiation Tool issued
- July – August 2026 – Revised Policy and Guidance issued
- July – August 2026 – Technical Assistance provided
- August 2026 – Local Proposed Goals submitted
- August – September 2026 – Local Negotiations conducted with OET

Eligible Training Provider List (ETPL)

- ETPL Coordinators working with New or Current Providers: PB2
 - Verification of information
 - Authorized to operate training programs
 - Accreditation and Accrediting Body information is accurate
 - Locations need to be verified
 - ONet/SOC - Training Program Critical Element
 - Discuss with Provider on associated ONet/SOC codes before immediate denial
 - Utilize and Share Demand Occupation Training List (DOTL) Notice and List PB1
 - Provide ALL Participants with State ETPL and discuss along with Local ETPL, if available
 - NEW Step: Recommend to State ETPL Coordinator
 - 30 Day Window to Recommend for ETPL or Recommend not meeting criteria



ETPL Changes

- Preparation for Transition – What Can You Do Now?
 - Continue Outreach to Training Providers
 - Upcoming 5-Session IWDS 2.0 ETPL Training Webinars
 - Summary of Transition Steps
 - Training Program Performance Due for PY24 & PY25 by August 15, 2026
- Procedural
 - Review Applications; Approve by June 25, 2026, if received by May 15, 2026
 - Expedite Applications received after May 15, if possible; Approve by June 25
 - Follow-Current Policy
- Training Program Performance
 - Report Submission for ALL Training Programs on ETPL in PY24 or PY25
 - Report on ALL Students enrolled in any Program on ETPL
 - Report is on ALL Programs, not programs with WIOA participant enrollments



ETPL Critical Information in IWDS 2.0

New List of Critical Information Requiring Review and Approval/Denial of Current Eligibility Period

• Training Provider Information

- *Training Provider Name
- *Approval or Accrediting Process recognized by the State of Illinois (IBHE, SOS, IDPFR, Industry-Recognized, etc.)
- *Name of Industry Recognized Accreditation
- *Name of Accrediting Body
- *Assurance of Compliance with nondiscrimination, equal opportunity, and disability provisions of the Workforce Investment Act of 1998? (29 CFR 37.20, 29 CFR 37.42 & 54)
- *Assurance of Accessibility to all people with a disability (29 CFR 32.3)

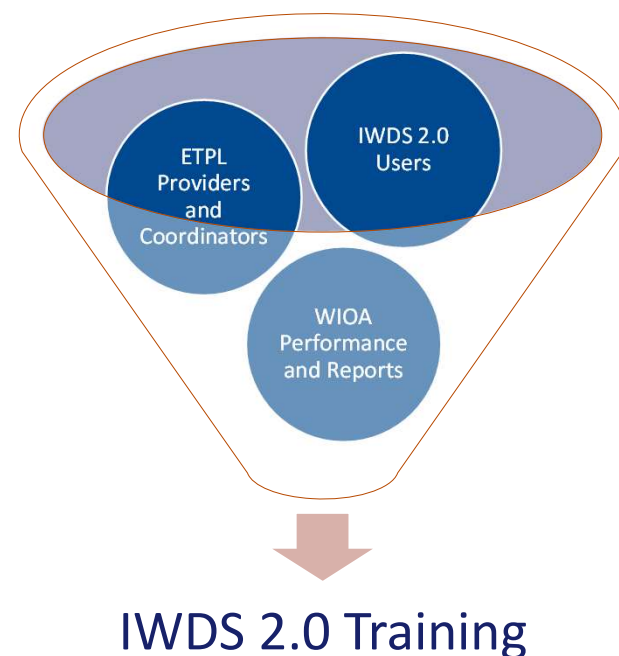
• Training Program Information

- Program Name
- Program Description
- *Location
- CIP (Classification of Instructional Programs) Code
- *SOC (Standard Occupation Code) also referred to as O*Net Code (Only if the change is removal of a SOC and there are no other demand occupation SOC identified for the program.)
- *Outcome Type
- *Name of Credential
- *Name of Accrediting Body

* Indicates new “critical” information

IWDS 2.0 Updates

- IWDS 2.0 Discovery and Development Continues
 - Weekly Subject Matter Expert meetings
 - Deployment scheduled for July 1, 2026
 - Data Migration June 26-30, 2026 (IWDS LOCKOUT)
- Regional Train-the-Trainer Model
 - Regional Trainers Training will occur in April – May 2026
 - Series of In-Person and Virtual Trainings
 - 5-Day Bootcamp (May 18-22, 2026)
- Statewide Trainings
 - 2-Day Regional Trainings (May 25-June 26, 2026)
 - ETPL WIOA Wednesday Webinars (May 27 – June 24, 2026)





Statistical Adjustment Model (SAM)

- Purpose
 - Provide predictive modeling of outcomes prior to Local Performance Negotiations
 - Compare with actual participant characteristics and economic conditions after each Program Year to develop adjustments to performance goals
- Dependent on Accurate Data
 - Inaccurate data affects career planning, quarterly/annual reporting, performance
- Timeliness is critical to get the information into the System
 - 10-day recording in system when informed of a new service or change to career plan
- Primarily focuses on individual challenges at Program Entry
 - IWDS 2.0 will track new information after program entry for better career planning
 - Will account for challenges identified after program entry that existed at enrollment



End-of-Year Report Submissions

- Program Year 2025 ends June 30, 2026
 - PY2025 Quarter 3 Reporting submitted to USDOL
 - PY2025 Quarter 4 Report will be submitted mid-August 2026
 - PY2025 Annual Report will be submitted in early September 2026
- LWIAs, grantees and other stakeholders responsible for entering participant information should ensure ALL PY2025 information is entered in IWDS or Career Connect no later than July 31, 2026.
 - ➡ Participant Services
 - ➡ Program Exit Dates
 - ➡ Employment Information
 - ➡ Post Exit Employment
 - ➡ Measurable Skill Gains
 - ➡ Credentials
 - ➡ Post Exit Employment
 - ➡ Case Notes and other information
- **REMEMBER: If it isn't reported, it didn't happen! Report to get credit.**
