Emphasizes:

- Jobseekers
- Employers
- Career pathways
- Training Systems
- Customer Support

What is the WIOA State Plan



Covers four core WIOA programs:

- Adult, Dislocated Worker and You
- Adult Education
- Wagner-Peyser Employment Services
- Vocational Rehabilitation

Sets:

- Vision and goals
- Strategies and Activities for accomplishing those vision and goals

Vision: An integrated, equitable workforce system that supports economic opportunity for individuals and meets the talent needs of employers across Illinois.

Key Strategies

Strengthen cross-agency coordination and service integration

Expand career pathways and sector-based strategies

Use data and performance measures to drive continuous improvement

Engage employers as active partners in system design and delivery

Why Is a Modification Required?



Federal requirement under WIOA

Required at least every two years

Changes include:

- Policy changes
- Strategic shifts
- Economic and labor market conditions

Why Is a Modification Is and Is NOT



ls:

Targeted updates

Strategy refinements

Adjustments to activities

Is Not:

A blank slate

A total rewrite

A single-agency exercise

What Sections Are Typically Modified?



Commonly updated sections:

- Economic and labor market analysis
- Strategies for achieving the vision
- Service delivery approaches
- Partner roles and coordination
