

## Overview:

Training program information is a critical component of the intake process. If program information is not entered into the system, customers cannot complete intake and be enrolled in the program. The intake process includes two main steps:

1. Customer completes the online intake form.
2. Staff complete the intake review by:
  - a. Reviewing the customer's intake form responses;
  - b. Comparing their responses to the training program requirements; and
  - c. Discussing the results and options with the customer to identify a good customer/program match.

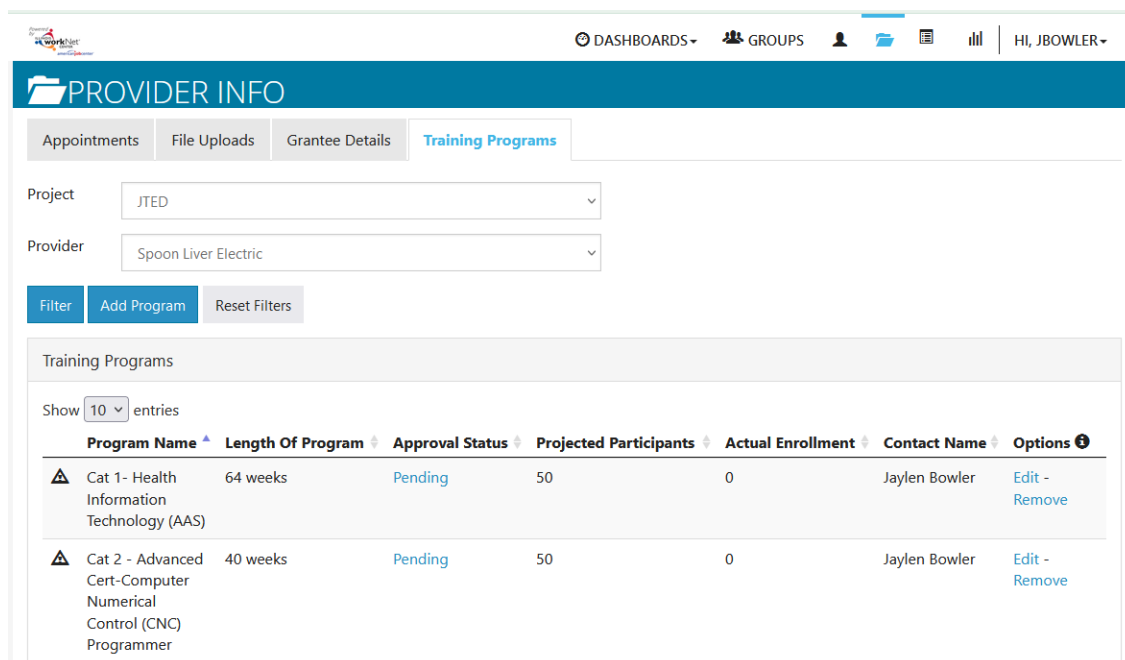
## Who Enters/Maintains Data:

**Grantee staff** associated with an agency/program in the Illinois workNet system can add/update training program information. It is the grantee's responsibility to add and maintain accurate training program information.

**Commerce grant managers** approve the program once the credentials associated with the program have been verified and all related information is complete and accurate.

## How to Access JTED Customer Support Center Tools:

1. Log into [www.illinoisworknet.com](http://www.illinoisworknet.com).
