Grant Close Out Requirements

Each grantee will need to complete and submit three documents to close out their Illinois Works Preapprenticeship Program 2022 grant.

These three documents are for grantees who were not renewed for 2023.

Once all three of these are submitted and approved, funding attached to Close Out reports will be released for reimbursement.
