

The intake process uses system generated recommendations in combination with a career planner review to ensure customers are suitable for a program. This process includes three main steps:

- 1. Customer completes the online intake form. Illinois workNet system uses the submitted forms to organize customers by grantee, generate program recommendations, and populate initial assessment results.
- 2. Staff completes the intake review by:
 - a. Reviewing the customer's responses related to employment goals and baseline questions.
 - b. Comparing their responses to the training program baseline requirements; and
 - c. Discussing the results and options with the customer to identify a good customer-to-program match.
 - d. Reviewing eligibility requirements and collecting the appropriate documentation.
 - e. Updating the eligibility status field to:
 - i. Submit the intake information to IWDS. (Note: At this point they are an IWDS Inquirant).
 - ii. Identify the reason why the customer is not going participate and to document recommended next steps or referrals.
- 3. Grantee staff schedule interested and eligible customers with an LWIA staff appointment to certify their application in IWDS.
 - a. Customers will need to take their eligibility documentation to the appointment.
 - b. Grantee staff provide the customer with next steps once their IWDS application is certified.
- 4. LWIA staff will complete the IWDS application and verify supporting eligibility documentation.
 - a. Information in the intake form has been aligned with IWDS field. The information populates IWDS once the grantee collects the eligibility documentation and uses Illinois workNet to submit the information to IWDS.
 - b. The intake form submit date will be the contact date that populates IWDS.
 - c. Once the IWDS application is certified, the customer is considered an IWDS Applicant.
 - d. At this point, the customer is considered enrolled in the Youth Career Pathways program.

Who Enters/Maintains Data:

Customers complete the intake form. Once submitted, the customer cannot update the information.

Provider staff can update their customer's online intake form based on their conversation with the customer. Updates can be made to the form up to the point where the customer's status changes from inquirant to applicant. At that point, the form is locked.

Provider staff accesses the customer's intake review page to discuss recommended programs, identify required eligibility documentation, and update eligibility status information.

How Customers Access the Youth Apprenticeship and Career Pathway Online Intake Form:

- 1. Go to <u>www.illinoisworknet.com/apply4ycp</u>.
- 2. Customers login with their existing Illinois workNet account. If they do not have an Illinois workNet account, they should setup an account.
- 3. Agree to the Terms of Use and complete the Get Recommendations section.
 - a. The system will provide training program recommendations based on their skills and interests. If the customer is interested in any of the programs, they can continue with answering baseline questions.
 - b. The system will provide training program recommendations based on their answers to baseline questions. If the customer is interested in any of the programs, they can continue with remainder of the intake form.
- 4. Complete the About You section. Customers can preview their answers and make updates. Once submitted, they will not be able to make changes.
- 5. Once started, the intake form is available in their Illinois workNet My Dashboard.

- 2. Review the Employment Goals to get a better understanding of their goals and a general idea of how much research they have completed in order to identify those goals.
 - a. Provide case notes as needed.
 - b. If changes are needed, Edit/Update the section.



- 3. Review the Select a Training Program section to see recommended and non-recommended training programs based on their response to nine "hard stop" baseline requirements.
 - Review program information with the customer and compare it to the customer's responses to "hard stop" and "non-hard stop" baseline questions. Select the training program name link to view the program information.
 - b. Update the recommendation status.
 - i. If the customer is interested in participating, select the customer's training program choice and update the recommendation status to Program Selected.

ii. If the customer is not going to participate, update the recommendation status to identify why they are not going to participate. Explain the referral or next steps that were provided to the customer.



4. Go to the Review WIOA Eligibility and Collect Documentation section. Review the information with the customer to make sure they understand the requirements and meet the eligibility requirements. Barriers selected in the customer's intake form will be checked in this section. Collect the required documentation for each barrier. Select the "Show" link to access a summary of information and policy links related to that requirement.
