WHEREAS, REGISTERED APPRENTICESHIP PROGRAMS ARE A PROVEN VEHICLE TO TRAIN INDIVIDUALS IN THE SKILLS NEEDED TO BE A JOURNEYMAN LABORER AND AN INVALUABLE TOOL TO TEACH OUR MEMBERS ON THE CURRENT AND UP AND COMING TECHNOLOGIES WITHIN OUR INDUSTRY. WHEREAS, GRADUATED APPRENTICES, HAVE THE KNOWLEDGE AND ABILITY TO PERFORM AS A LIUNA JOURNEYMAN AT AN ENHANCED LEVEL, ULTIMATELY GIVING ENHANCED CREDIBILITY TO OUR TRADE AND TO THE INDUSTRY. A GRADUATED JOURNEYMAN ALSO HAS THE TOOLS NEEDED TO INFORM AND ASSIST CURRENT APPRENTICES IN THE IMPORTANCE OF COMPETENCE IN THE WORKPLACE AS WELL AS VARIOUS SOCIAL ASPECTS WHICH GOVERN THE WELFARE OF THE INDUSTRY, AND

WHEREAS, IN CERTAIN AREAS, COMPLETION OF A REGISTERED APPRENTICESHIP PROGRAM CAN ALLOW GRADUATES TO OBTAIN THE CREDITS NEEDED TO PURSUE AN ASSOCIATES DEGREE WITH ONLY HAVING TO OBTAIN AN ADDITIONAL 30 CREDIT HOURS AT A PARTICIPATING HIGHER EDUCATION INSTITUTION, AND

NOW, THEREFORE, BE IT RESOLVED THAT THE MIDWEST REGION OF LABORERS' INTERNATIONAL UNION OF NORTH AMERICA, CALL UPON ALL OTHER TRADES AND INDUSTRY PARTNERS TO RECOGNIZE THE IMPORTANCE AND VALUE OF REGISTERED APPRENTICESHIP PROGRAMS AND TO TAKE INTO MEASURE THE NEEDS OF THE SKILLED WORKFORCE MOVING FORWARD DURING NATIONAL APPRENTICESHIP AWARENESS AND APPRECIATION WEEK, NOVEMBER 8-14, 2020.
