The Interagency Work Group, consisting of State-level required partners under WIOA, reviewed all regional plans, local plans, and memoranda of understandings (MOUs) in accordance with Federal and State requirements under WIOA. This dashboard provides the public with access to all Plans and MOUs with the status of Approved/Approved with Technical Changes. Contact <u>info@illinoisworknet.com</u> with any questions.

The dashboard is a searchable list of every regional plan, local plan and MOU and gives you the ability to:

- Search by Keyword;
- Filter by EDR, LWIA, Document Type, and Approval Status;
- Filter by dates to find documents active during a specific time; and
- Preview and download documents that are Approved/Approved with Technical Changes.

Finding Active Documents:

- Use the Document Effective and Document Expires column to verify you looking at active documents.
- Documents are typically named starting with PY##, this reflects the program year the document was submitted for. For example, PY20 refers to Plans and MOU documents submitted for Program Year 2020.
