- Create 5 (100 or fewer employees) or 25 new full time positions.



WOTC – Work Opportunity Tax Credit

- \$1200 \$9600 depending upon the category.
- Who can you hire?
 - Veterans
 - TANF Recipients
 - SNAP (Food Stamp) Recipients

 - Vocational Rehabilitation Referral
 - Ex-Felons


