# Pseudo Monetary Determination Screen

- The Pseudo Monetary Determination screen displays quarterly wages which have been reported by Illinois employers for a specific SSN. Users may view a claimant's potential Weekly Benefit Amount (WBA) and Dependent Allowance.
- To view the screen for a particular claimant, users may enter the claimant's SSN and click the Display button. To search on other claimant attributes, users may click on the Claimant Lookup magnifying glass icon next to the Claimant ID field which will display the Claimant Lookup popup.
- To view different quarters, users may update the BYB field above the table and click the Set Dates button.
- The table will show the reported wages for the five complete quarters prior to the entered BYB.
- Clicking the Reset button will return the screen to the default period.
